

# Terms and Conditions Saints Shopping's Christmas Giveaway Facebook Competition 2024

#### Key Terms:

Information on how to enter and win the prize form part of these conditions. By participating, entrants thereby acknowledge they have read, understood, and agree to these terms and conditions. Entries must comply with the conditions to be valid.

#### **Eligible Entrants:**

- 1. Entry is open to all permanent South Australian residents aged 18 years and over.
- 2. Employees (and their immediate families) of the Promoter or retailers, are not eligible to enter Saints Shopping's competitions. Immediate family means any of the following: spouse, exspouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, brother, sister, step-brother or step-sister.
- 3. Entrants may only enter once. Multiple entries are not permitted.
